BOADICEA SHAREHOLDERS APPROVE ASSET SALE TO IGO LIMITED

A General Meeting of Boadicea Resources Ltd (ASX: BOA) was held online today, Wednesday 14 October 2020, commencing at 11am AEDT.

In accordance with Listing Rule 3.13.2 and section 251AA of the Corporations Act 2001 (Cth), we advise details of the Resolution and the proxies received in respect of the Resolution as set out in the attached summary.

The Resolution put to the Meeting was passed on a Poll, and the Board of Boadicea thanks shareholders for their ongoing support.

As a result of the Resolution being carried, the condition precedent to the Asset Sale of nine (9) defined tenements in the Fraser Range to IGO Limited (refer ASX announcement made on 4 September 2020) has been satisfied.

The Trading Halt announced 13 October 2020 is expected to be lifted immediately following release of this announcement, and shareholders should note the following events now scheduled to occur:
